Introduction

The Center for Health Information and Analysis (CHIA) reports on the annual and quarterly financial performance of acute hospitals. As the financial performance of hospital health systems is important to understanding the greater context in which hospitals operate, CHIA has expanded reporting to include the financial performance of hospital health systems, physician organizations (PO), and related health plans.

In Fiscal Year (FY) 2016, Massachusetts had 30 hospital health systems and 63 acute hospitals. Hospitals are grouped into five cohorts: Academic Medical Centers (AMC), teaching, community, High Public Payer (HPP), and specialty. Eleven hospital health systems are multi-acute systems that operate more than one acute hospital. Nineteen systems are single acute hospital health systems. Three systems (Tenet Healthcare, Trinity Health Care Inc., and Shriners Hospitals for Children) are part of larger systems that operate hospitals nationwide.

Hospital health systems consist of all consolidated health entities, including acute hospitals, non-acute hospitals, physician organizations, and health plans. They may also include consolidated non-health care entities such as foundations and real estate trusts.

Steward Healthcare did not submit the required hospital level or system level audited financial statement data. As such, financial data for Steward's acute hospitals were sourced from the Center for Medicare and Medicaid 2552 Hospital Cost Report. As there was no publicly available data source for the system level and physician organization data, this information could not be included in this report.

This report contains 12 months of data for FY 2016 for all systems and hospitals regardless of the year end. Most hospitals' fiscal year end is September 30, with the exception of Steward Healthcare, Trinity Health, Cambridge Health Alliance, Tenet Healthcare, and Shriners Hospitals for Children, which have alternative fiscal year ends.

Baystate Mary Lane Hospital merged with Baystate Wing Hospital on September 10, 2016. Baystate Mary Lane Hospital only submitted an income statement for FY 2016 activities. As such, the hospital's data is included in statewide and acute cohort medians for profitability.

This publication reports on the profitability, liquidity, and solvency of hospital health systems, acute hospitals, physician organizations, and health plans.

KEY FINDINGS

In 2016, the majority of parent systems that provided data, 22 out of 29, reported a profit.

The majority of acute hospitals reported a profit in FY 2016. Forty-seven out of 63 acute hospitals reported a profit in FY 2016.

The statewide median acute hospital total margin was 3.1%, which is a 0.7 percentage point decrease between FY 2015 and FY 2016.

The statewide median acute hospital operating margin is 2.6%, which is a 0.6 percentage point decrease between FY 2015 and FY 2016.



Acute hospitals tended to have greater margins than their associated parent systems.



Most physician organizations reported a financial loss in FY 2016.

The statewide median current ratio was 1.8, which is a 0.2 point increase between FY 2015 and FY 2016.

Fifty-eight hospitals had positive net assets in FY 2016.

PROFITABILITY

Total margin reflects the excess of total revenues over total expenses, including operating and non-operating activities such as investment income, as a percentage of total revenue.

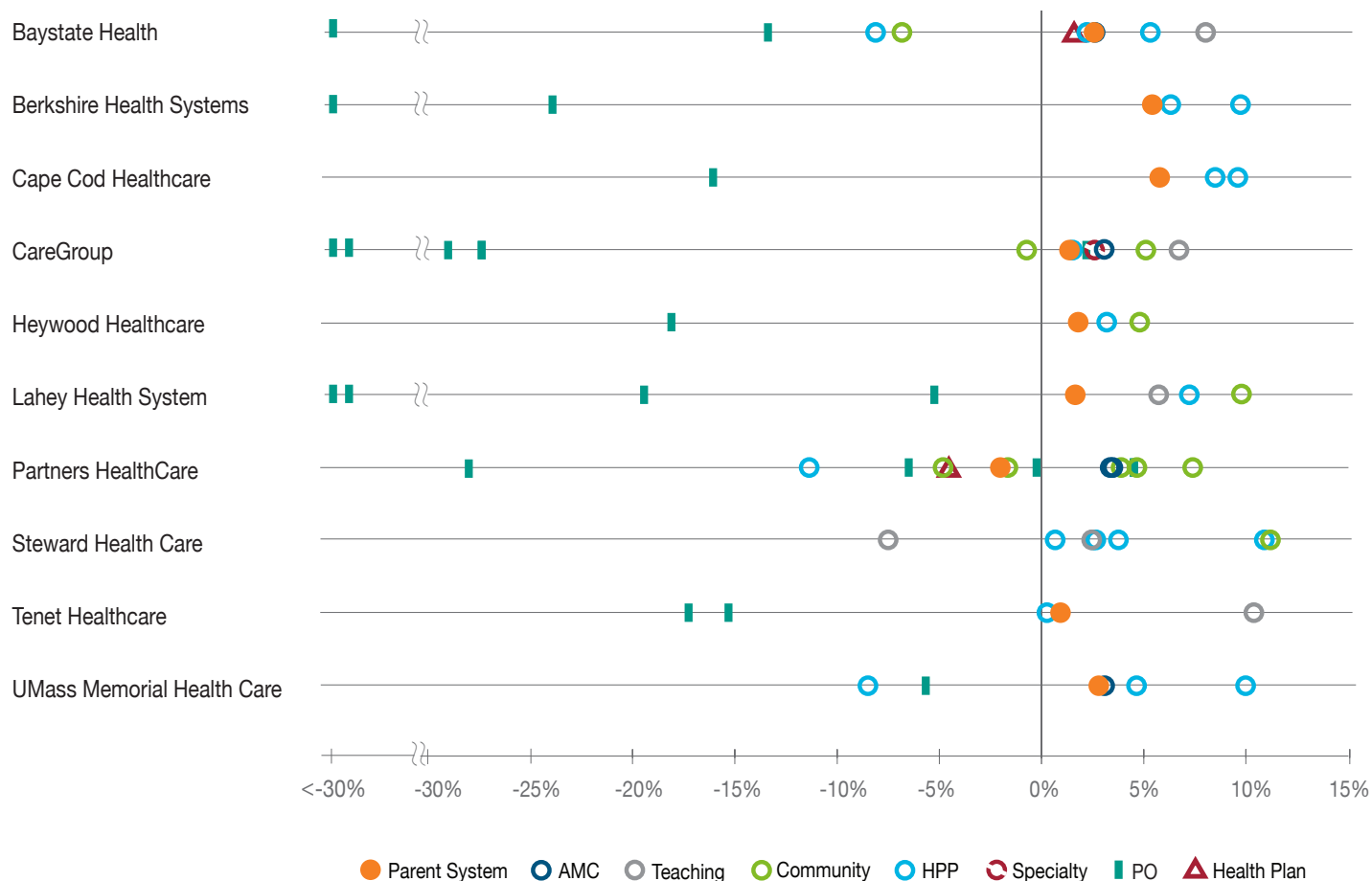
Nine of the 10 multi-acute systems that reported data were profitable. The total margin for these systems ranged from -2.0% for Partners HealthCare to 5.8% for Cape Cod Healthcare. The component acute hospital total margins ranged from -11.4% for Partners' North Shore Hospital to 11.2% for Steward Norwood Hospital.

Most associated physician organizations reported negative margins. One associated health plan reported a loss and one reported a profit.

In general, acute hospitals performed better than their parent systems and related entities.

PROFITABILITY

FY 2016 Total Margin for Independent Health Systems

by Component Entity

Thirteen out of 19 independent acute systems reported a profit in FY 2016. Hospital health system performance ranged from -4.7% at Hallmark Health to 7.7% at Sturdy Memorial. Acute hospital performance ranged between -3.2% at Cambridge Health Alliance to 10.7% at Sturdy Memorial Hospital. As was the case for multiple acute hospital systems, independent acute hospitals tended to perform better than their parent systems.

Most associated physician organizations reported negative margins. The associated health plan reported a loss.

PROFITABILITY

Operating margin is the ratio of operating income/loss to total revenue. It reflects revenues and expenses associated with patient care activities, but does not include investments, research, and other non-operating revenues or expenses.

Of the ten multi-acute hospital systems that reported data, eight reported a positive operating margin. Parent system performance ranged from -0.9% for Partners HealthCare to 4.5% for Cape Cod Healthcare. Acute hospital performance varied between -11.6% for Partner's North Shore Hospital to 11.2% for Steward Norwood Hospital.

Similar to total margin, most physician organizations reported negative operating margins. One associated health plan reported an operating loss and one reported an operating profit.

PROFITABILITY

Nine out of the 19 systems reported a positive operating income. Parent system operating margins ranged from -7.9% at Hallmark Health to 3.5% at Sturdy Memorial Foundation.

Among acute hospitals, operating performance ranged from -5.3% at Cambridge Health Alliance to 7.2% at Southcoast Hospital.

Most associated physician organizations reported an operating loss. One associated health plan reported an operating loss.

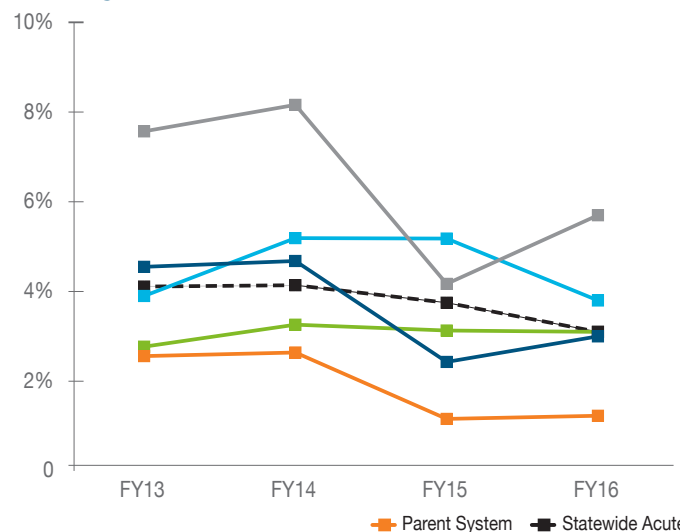
FY 2013 - FY 2016 Total and Operating Margin Trends

by Hospital Cohort

The statewide median for both total margin and operating margin decreased modestly between FY 2015 and FY 2016. The AMC and teaching cohorts' median total margin increased by 0.6 and 1.5 percentage points, respectively, while the community hospital cohort's median total margin remained the same. The community-HPP cohort's median total margin decreased by 1.4 percentage points. The total margin for parent systems remained the same at 1.2%.

All cohorts' operating margin decreased between FY 2015 and FY 2016. The largest decrease was in the community-HPP cohort, which decreased by 1.6 percentage points. Parent systems' operating margin decreased by 0.3 percentage points between FY 2015 and FY 2016.

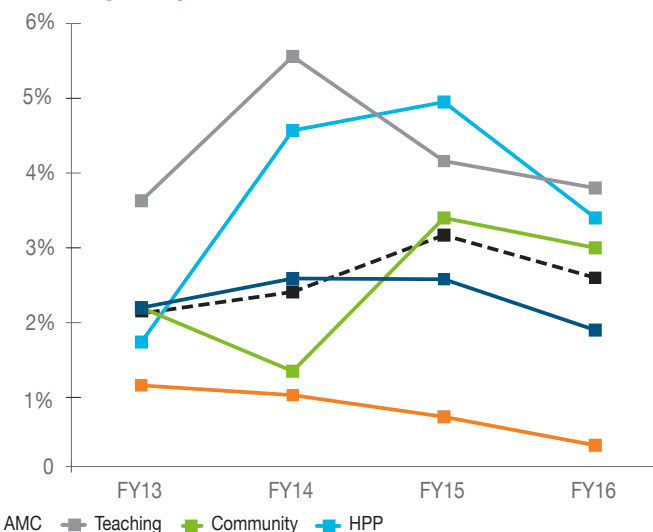

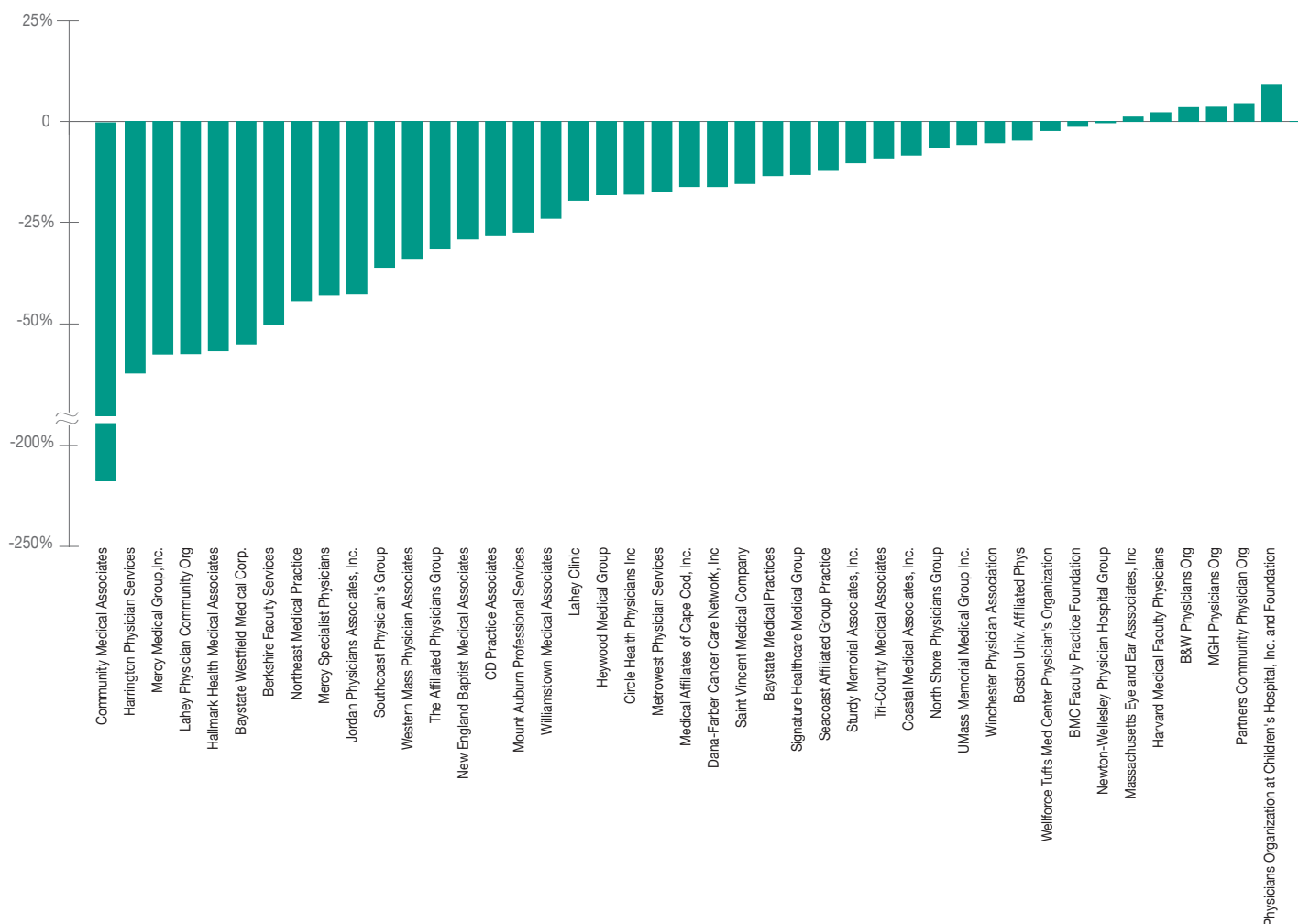
FY 2016 Physician Organization Total Margin

Physician organizations vary greatly in terms of size, services provided, and specialty. The total revenue reported by these organizations ranged from \$1.7 million to \$1 billion in FY 2016.

The median total margin for physician organizations was -16.1%. Total margins and the amount of profits and losses varied greatly. This variation did not appear to be related to whether a physician was affiliated with a multi or individual acute hospital health system.

The majority of physician organizations, 37 of 43, reported losses in FY 2016. Losses ranged from \$223,000 for Newton-Wellesley Physician Hospital Group to \$64 million for Southcoast Physician's Group.

The largest physician organizations with the highest total revenue reported the largest profits. They were Physicians Organization at Children's Hospital and Massachusetts General Hospital Physicians Organization, which reported profits of \$65 million and \$36 million, respectively.

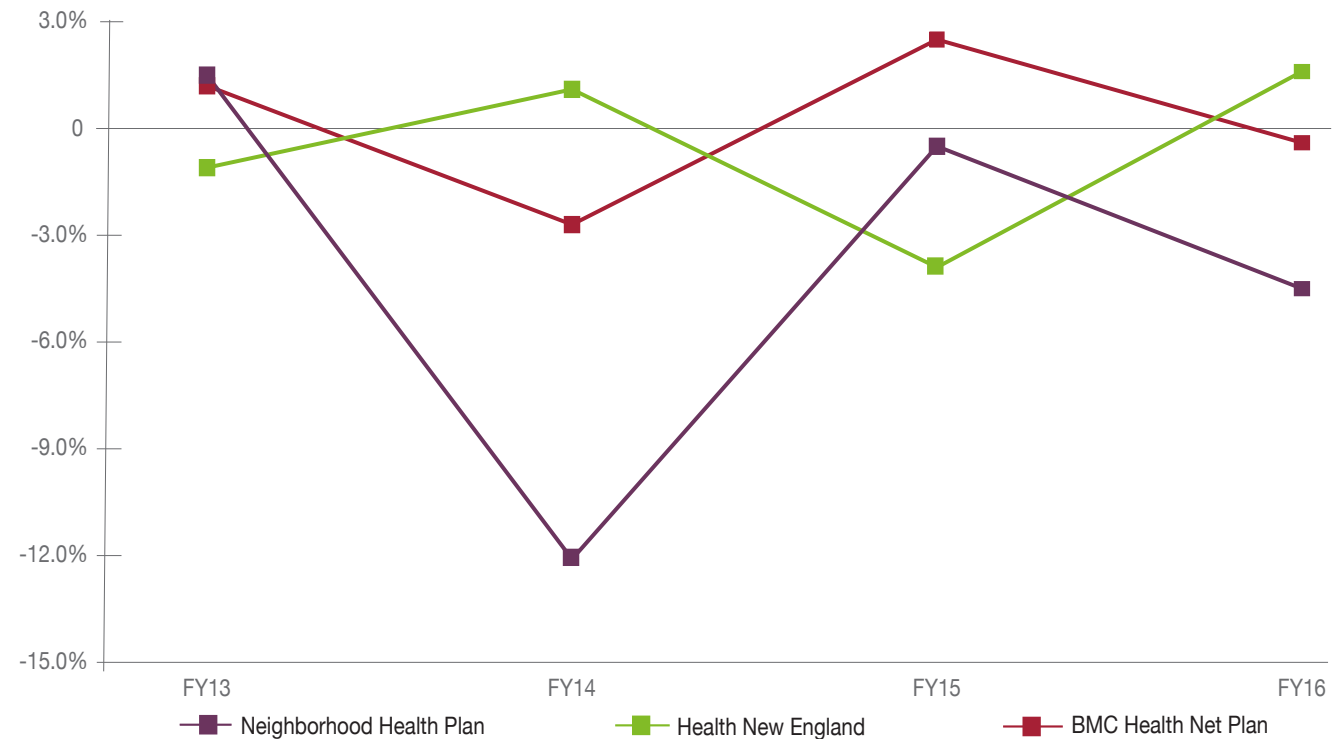
Emerson Health System does not wholly own its physician organization and Cambridge Health Alliance reports its physician organization as an integrated component of the acute hospital.

PROFITABILITY

FY 2013 - FY 2016 Health Plan Total Margin Trend

Three systems are associated with health plans: Baystate Health, Boston Medical Center and Affiliates, and Partners Healthcare. In FY 2016, Baystate Health's Health New England Plan was the only affiliated health plan that reported a profit.

Health plan financial performance varied from year to year. Partner's Neighborhood Health Plan reported losses for the past three years. Boston Medical Center's Health Net Plan reported a loss in FY 2016 and FY 2014 but was profitable in FY 2015 and FY 2013.

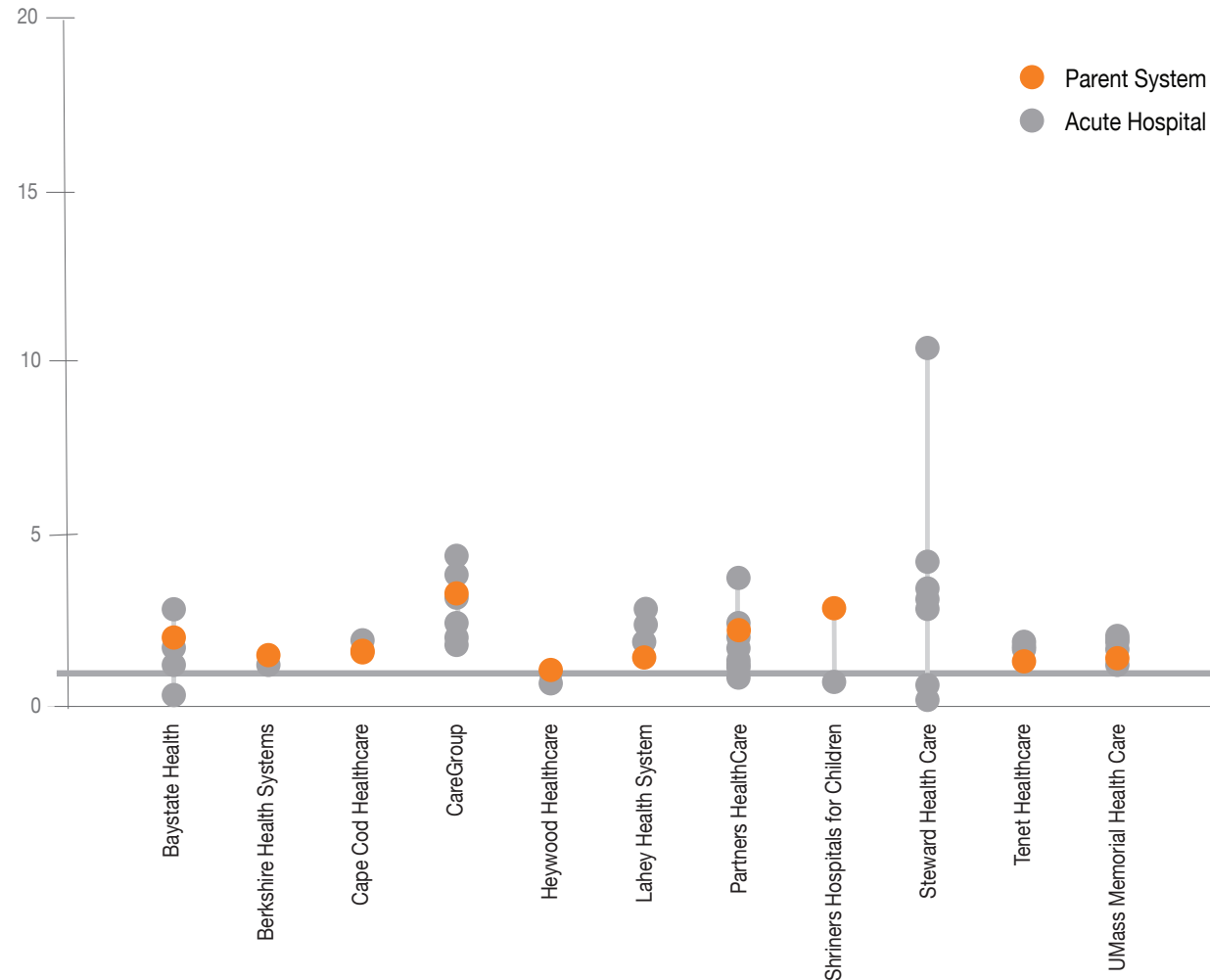
LIQUIDITY

Current ratio measures short-term financial health and indicates whether an entity is able to meet current liabilities with current assets. A ratio of 1.0 or higher indicates that current liabilities could be adequately covered by existing current assets and indicates financial stability.

All of the systems with multiple acute hospitals that provided data reported a current ratio above 1.0. Several acute hospitals reported a current ratio below 1.0, including Athol Memorial Hospital, Baystate Noble Hospital, Cooley Dickinson Hospital, three Steward Health Care hospitals and both Shriners Hospitals.

Steward Saint Anne's reported the highest current ratio, at 10.4.

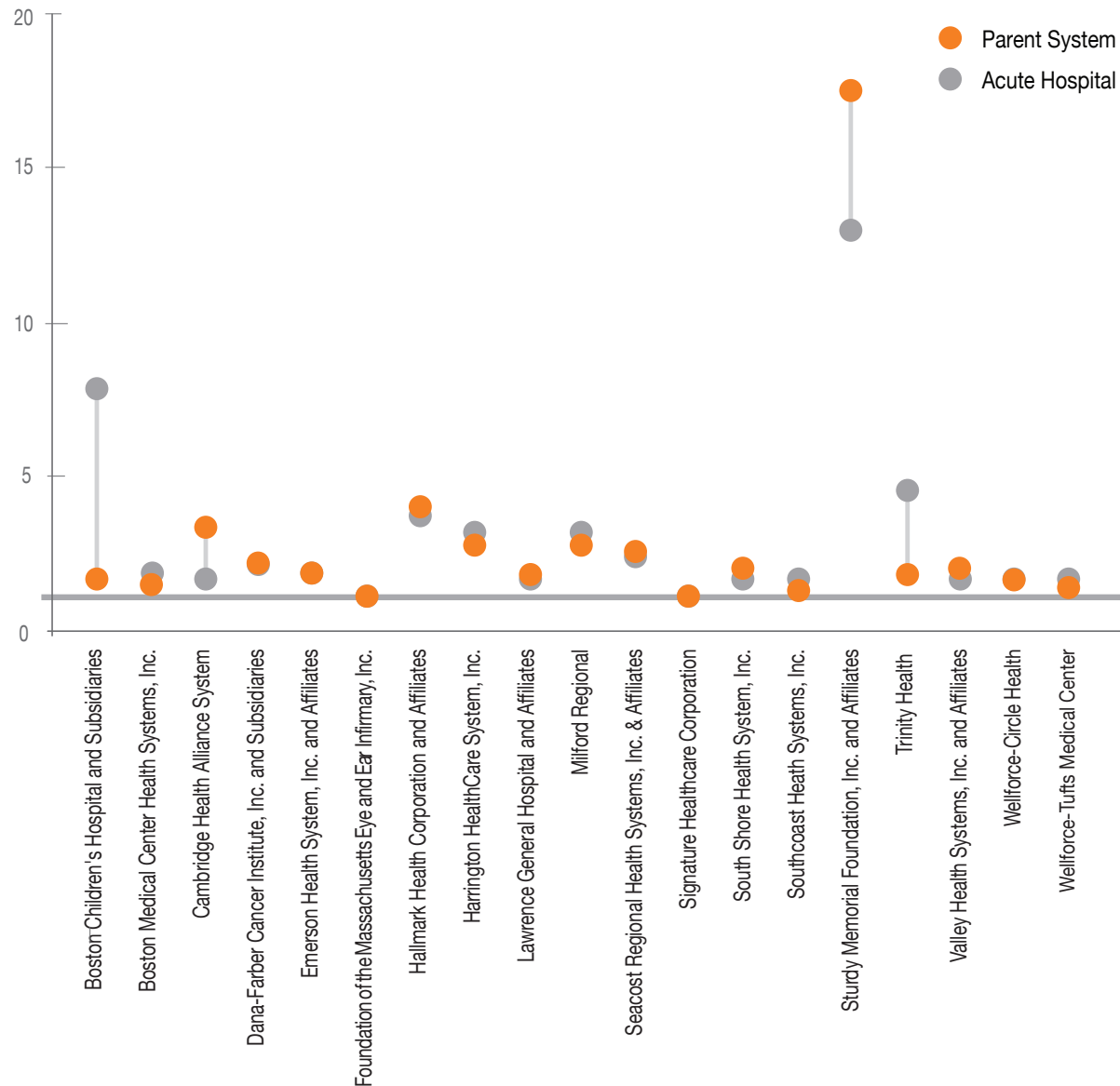

LIQUIDITY

In FY 2016, all independent health systems reported a current ratio above 1.0, indicating that current liabilities could be met with existing current assets. Parent system current ratios ranged between 1.0 for the Foundation of the Massachusetts Eye and Ear Infirmary and 17.5 for Sturdy Memorial Foundation.

Acute hospitals associated with independent health systems had positive current ratio measures as well, as all hospitals reported a current ratio above 1.0. Performance ranged between 1.1 for both Massachusetts Eye and Ear Infirmary and Signature Healthcare Brockton Hospital and 13.0 for Sturdy Memorial Hospital.

FY 2016 Current Ratio for Independent Health Systems

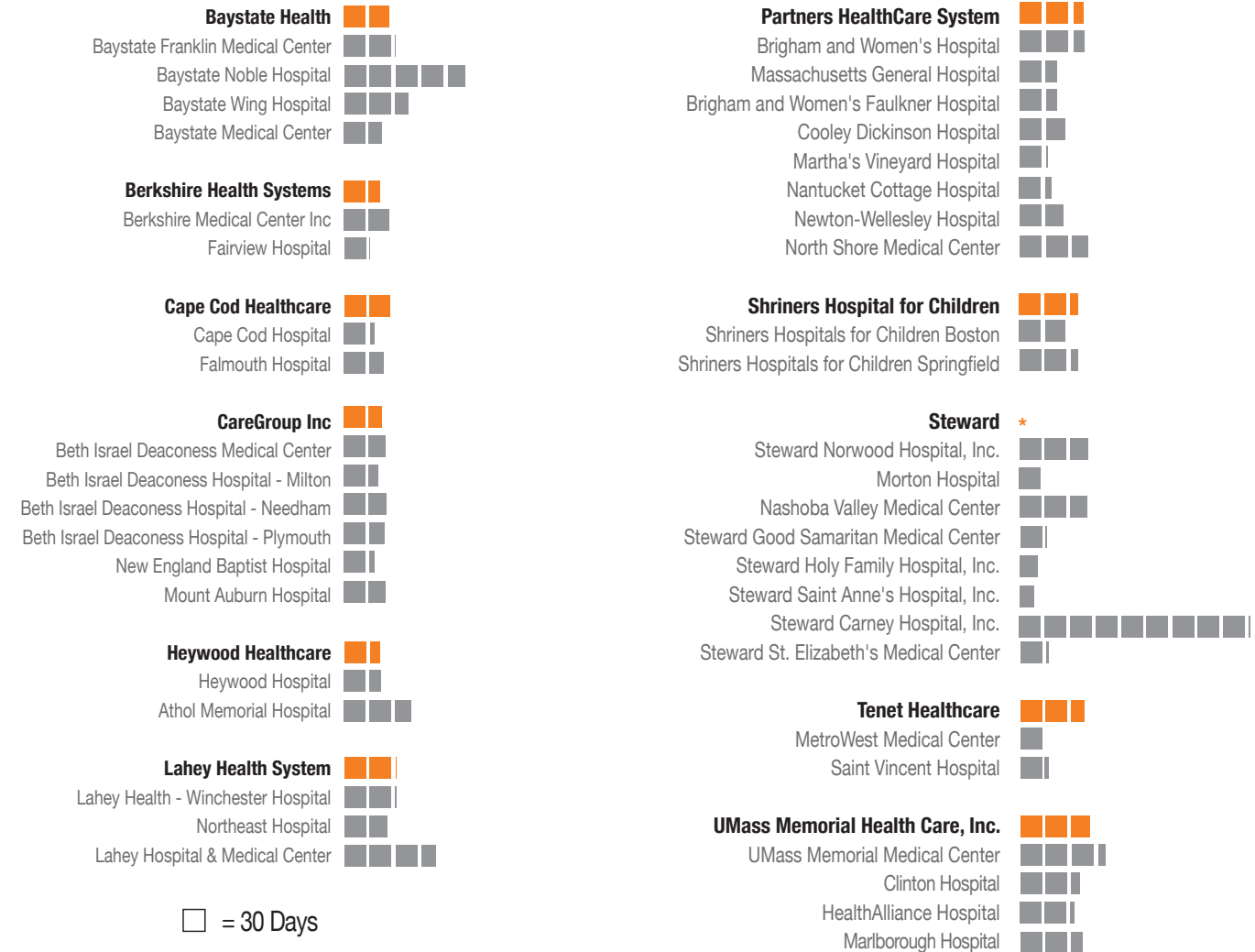


LIQUIDITY

Average payment period measures the time it takes hospitals to pay current liabilities. Higher values may indicate potential liquidity problems and an inability to pay current obligations. Average payment period ranged from 43 days for Heywood Healthcare to 86 days for UMass Memorial Healthcare.

Ranges for associated acute hospitals vary from 19 days for Steward Saint Anne's Hospital and 273 days for Steward Carney Hospital. Four hospitals had payment periods of 100 days or greater, which includes Baystate Noble Hospital, Lahey Hospital & Medical Center, Steward Carney Hospital, and UMass Memorial Medical Center.

LIQUIDITY

In FY 2016, average payment periods for independent systems ranged from 30 days for Seacoast Regional Health Systems to 98 days for Trinity Health.

Average payment period for acute hospitals associated with independent health systems ranged from 32 days for Anna Jacques Hospital to 202 days for Massachusetts Eye and Ear Infirmary. Massachusetts Eye and Ear Infirmary was the only hospital member of an independent health system that had an average payment period above 100 days.

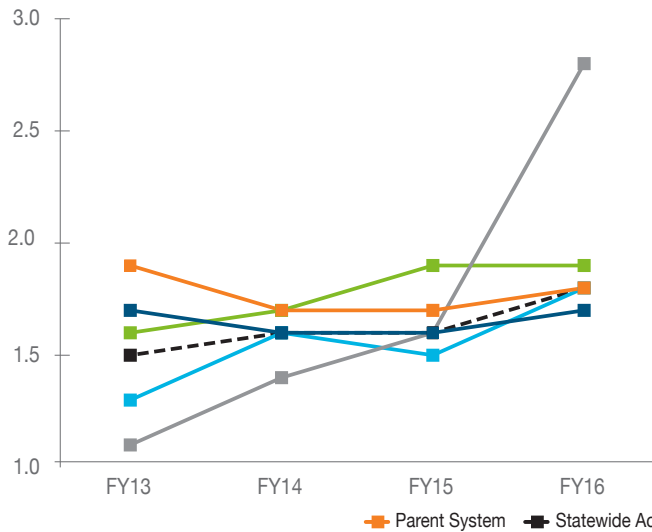
FY 2013 - FY 2016 Current Ratio and Average Payment Period Trends

by Hospital Cohort

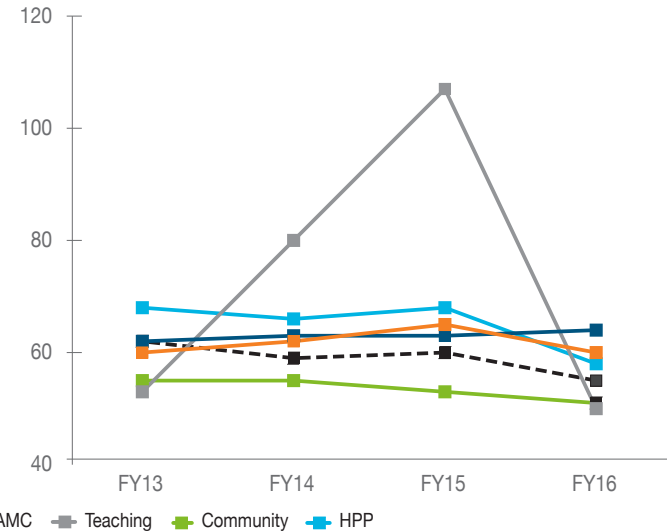
The FY 2016 statewide median current ratio was 1.8, an increase of 0.2 points from FY 2015 to FY 2016. The current ratio also increased for all cohorts. The teaching cohort saw the greatest increase in current ratio, by 1.2. Parent system current ratio was 1.8, which is a 0.1 increase from FY 2015 to FY 2016.

The statewide median average payment period decreased by five days. The teaching, community, and community-HPP cohorts saw decreases in the median average payment periods, while the AMC cohort saw a minor increase in the median average payment periods, while the AMC cohort saw a minor increase in the median average payment period. The teaching cohort saw the most significant change in the median average payment period. In FY 2016, the median average payment period decreased by 57 days from FY 2015.

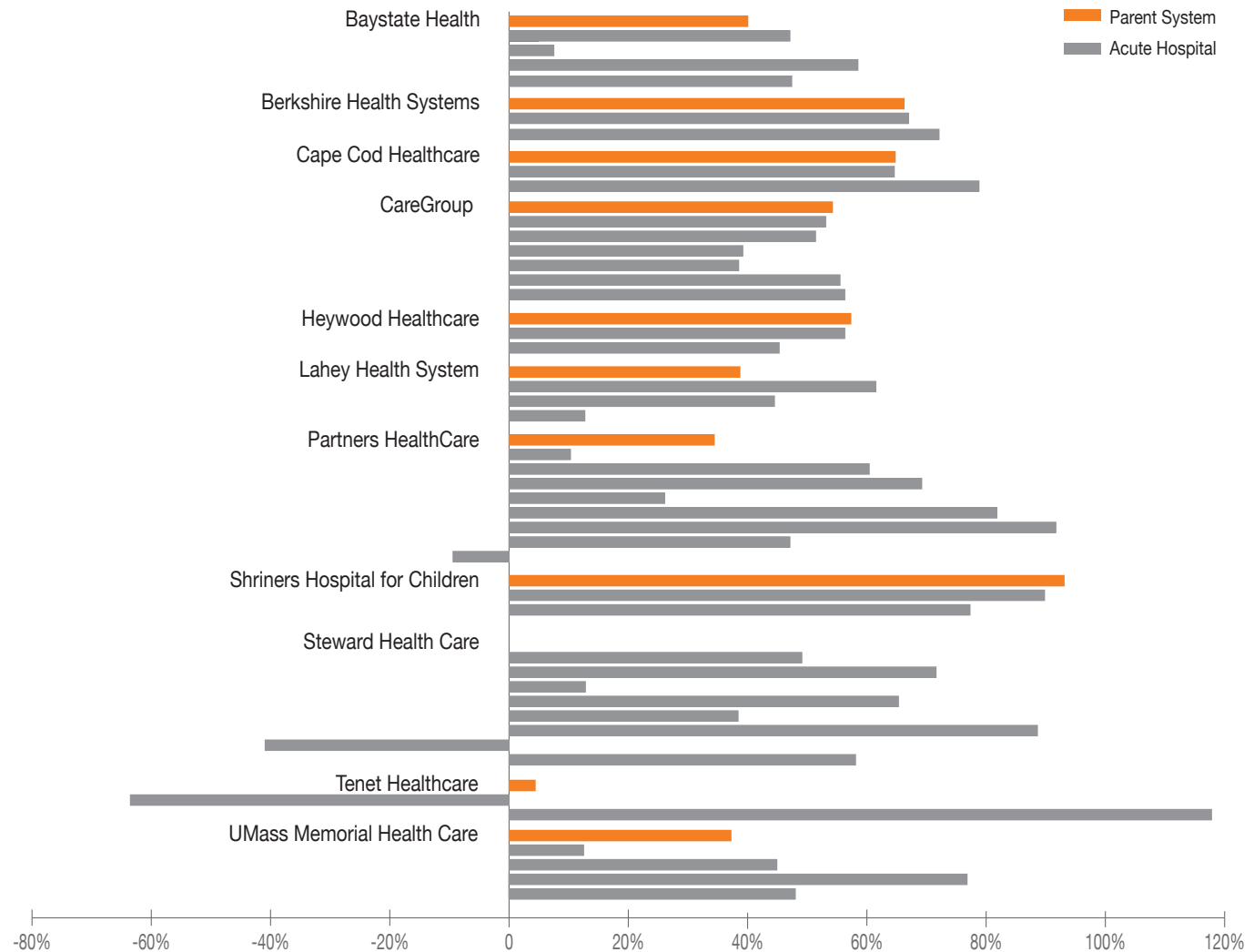

SOLVENCY

The equity financing ratio measures the proportion of total net assets financed with the hospital's equity and reflects the ability of a hospital to take on more debt. High values indicate hospitals with little or no long-term liabilities. Lower values indicate hospitals that are highly leveraged. Of the multiple acute hospital systems, the lowest equity financing value was 4.4% for Tenet Healthcare and the highest value was 93.1% for Shriners Hospital for Children.

Three hospitals, MetroWest Medical Center, North Shore Hospital, and Steward Carney Hospital reported negative equity financing, indicating that these hospitals are highly leveraged. Saint Vincent Hospital reported the highest equity financing ratio at 117.8%.

SOLVENCY

Equity financing values for independent health systems ranged from -19.2% for Holyoke Medical Center and 90.2% for Sturdy Memorial Hospital. The health systems for these hospitals also represented the minimum and maximum values for equity financing for independent health systems. Valley Health Systems, the parent system for Holyoke Medical Center, reported an equity financing ratio of -5.3% while Sturdy Memorial Foundation reported 90.0%. This indicates that both the acute hospital and parent system for Holyoke Medical Center are highly leveraged. Sturdy Memorial Hospital and its parent system, Sturdy Memorial Foundation, had little to no long term debt.

FY 2016 Equity Financing Ratio for Independent Health Systems



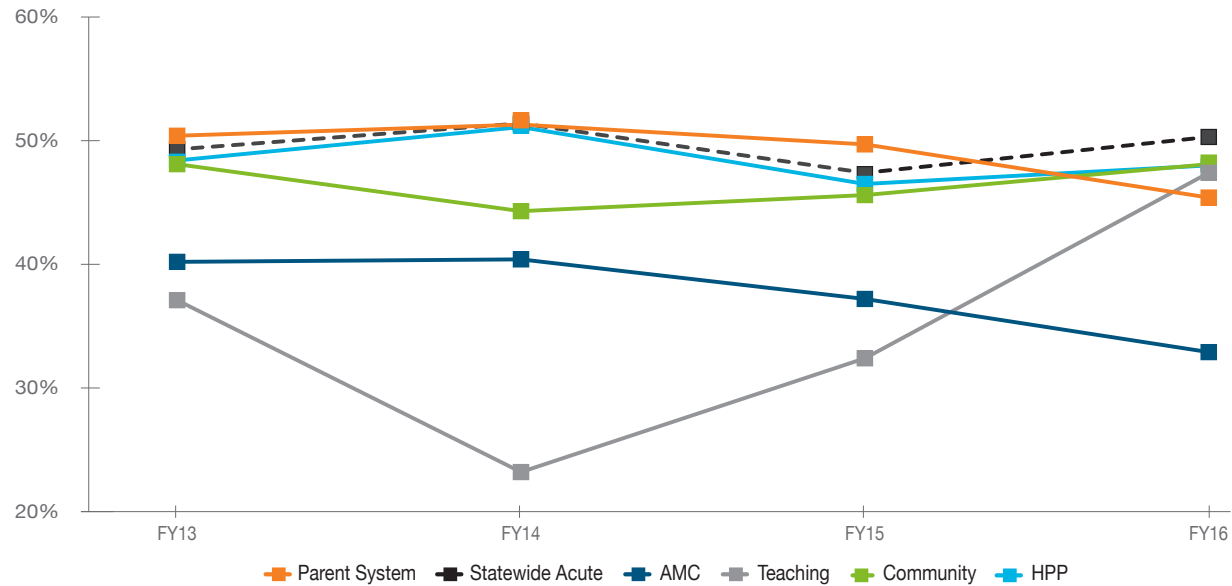
SOLVENCY

FY 2013 - FY 2016 Equity Financing Trends

by Hospital Cohort

The statewide equity financing ratio increased in FY 2016, indicating that hospitals are less leveraged by debt. The teaching, community, and community-HPP ratio increased, while the AMC cohort median equity financing ratio decreased. The equity financing ratio was lowest for the AMC cohort, which was 17.4 percentage points lower than the statewide median. This indicates that the AMC cohort is more highly leveraged than the median for the state. The teaching cohort ratio increased by the largest amount, by 15 percentage points. Parent system equity financing decreased in FY 2016 by 4.3 percentage points.

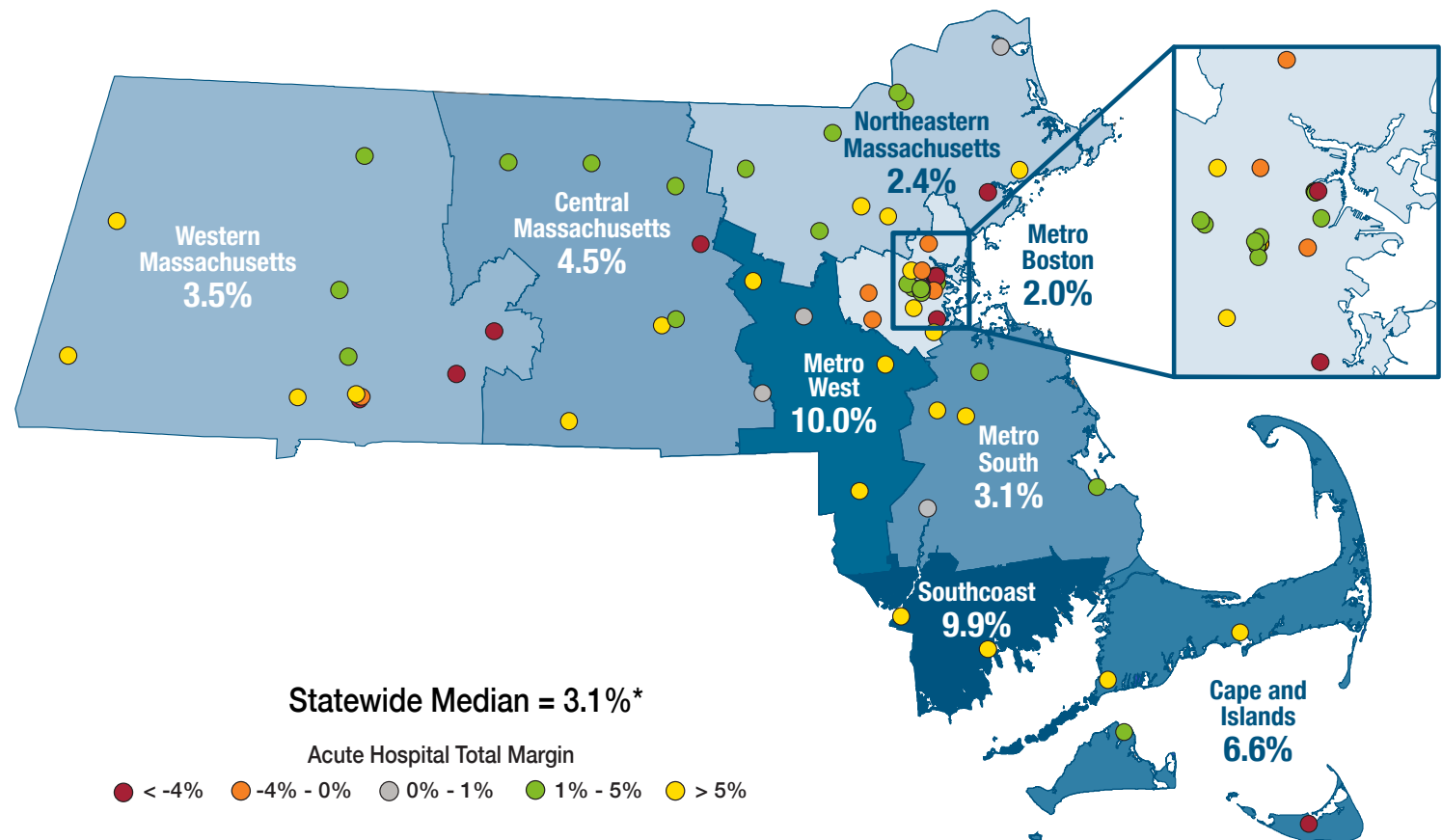

PROFITABILITY

FY 2016 Acute Hospital Total Margin by Region

There were a few notable differences in the financial performance of acute hospitals across Massachusetts regions in FY 2016. The Metro Boston and Northeastern Massachusetts region showed the lowest median total margins at 2.0% and 2.4%, which are below the statewide median of 3.1%. The Southcoast and Metro West region had the highest medians at 9.9% and 10.0%, well above the statewide median. The number of hospitals per region varies greatly, as some regions have a dense concentration of acute hospitals. The Metro Boston region contains 19 hospitals, while the Southcoast region contains two hospitals.

Acute Hospital and Health System Fiscal Year-End Dates

The Fiscal Year 2016 analysis is based on 12 months of financial data for all entities. The majority of health systems and hospital's fiscal year end date is September 30. Cambridge Health Alliance and Mercy Medical Center have a June 30 year end date, and MetroWest Medical Center, Saint Vincent Hospital, Shriners Hospitals, and Steward Health Care System's eight hospitals have a December 31 year end date.

Data Caveats

Baystate Mary Lane Hospital merged with Baystate Wing hospital during FY 2016. Kindred Boston and Kindred North Shore were sold to Curahealth and are now rehabilitation hospitals. As such, they are not included in this report. Tufts Medical Center and Circle Health (Lowell General Hospital's parent) formed Wellforce in FY 2015. They were not financially consolidated during FY 2015 and FY 2016; therefore their data is reported separately.

Acute Hospital Cohort Definitions

Acute hospitals were assigned to one of the following cohorts according to the criteria below. Please note that some AMCs and teaching hospitals have High Public Payer (HPP) status; this has been noted throughout the report where applicable.

Academic medical centers (AMC) are a subset of teaching hospitals. AMCs are characterized by (1) extensive research and teaching programs, and (2) extensive resources for tertiary and quaternary care, and are (3) principal teaching hospitals for their respective medical schools, and (4) full service hospitals with case mix intensity greater than 5% above the statewide average.

Teaching hospitals are those hospitals that report at least 25 full-time equivalent medical school residents per 100 inpatient beds in accordance with Medicare Payment Advisory Commission and which do not meet the criteria to be classified as AMCs.

Community hospitals are hospitals that do not meet the 25 full-time equivalents medical school residents per 100 beds criteria to be classified as a teaching hospital and have a public payer mix of less than 63%.

Community-high public payer (HPP) are community hospitals that are disproportionately reliant upon public revenues by virtue of a public payer mix of 63% or greater. Public payers include Medicare, MassHealth and other government payers, including the Health Safety Net.

Specialty hospitals are not included in any cohort comparison analysis due to the unique patient populations they serve and/or the unique sets of services they provide. However, specialty hospitals are included in all statewide median calculations.

Regional Definitions

The geographic regions presented in this report are derived from the Health Policy Commission (HPC) static geographic regions.
