## MA APCD 2026 Updates

- All APCD files including any re-submissions or overdue files must be in 2026 format (applies to reporting periods January 2023 onward).
- If historical Member Eligibility (ME) production files (Submission Year prior to 2026) need to be resubmitted, they must be accompanied by a corresponding Member Simplified (MS) file for the same submission period(s). For example, if resubmitting the January 2024 Member Eligibility file, you must also submit a January 2024 Member Simplified file in the 2026 format.
- ME & MS files need to link using the Carrier Specific Unique Member ID (CSUMID).



## MA APCD 2026 Updates

- Production files through May 2026 are due by June 30<sup>th</sup>.
- Please send any overdue files ASAP and report any issues or delays to your liaison.
- CHIA's Enrollment Trends report as well as the DOI HMO Membership report and the Claims Utilization report (with data through March 2026) are dependent on timely submissions of Q1 2026 data.
- Be sure to use FileSecure v7.3.4 when sending production data.



## Enrollment Trends Update

- The next Enrollment Trends reporting cycle will be based on data through **March 2026** and is scheduled to be published in Fall 2026.
- Thank you to payers that submitted Supplemental data through March 2026.
- CHIA typically sends out Payer Verification workbooks to verify eligibility data from the ME file in early June. Due to the transition to new Member Simplified (MS) file and new layout for Member Eligibility (ME) file, the Verification workbooks have been delayed.
- CHIA plans to send them out as soon as possible and will keep you posted through your liaison if we expect delays longer than a few weeks.
